## **About the NWT Arts Logo**

The NWT Arts Logo is a special mark that is owned by the GNWT. Only artists registered in the NWT Arts Program can use the NWT Arts Logo to promote, market, sell or display their artwork. Registered artists are supplied with promotional items (stickers and tags) to apply to their artwork before retail sale. Electronic copies of the logo can also be requested for use on websites, Facebook pages and other promotional materials.

It is the responsibility of the retailer to ensure artwork in their store that carries the NWT Arts Logo, has indeed been made by an artist that is registered with the NWT Arts Program. Retailers are not permitted to tag artwork made by NWT artists that are not registered with the NWT Arts Program.

The NWT Arts Logo can only be used in certain ways. The NWT Arts Logo Use Guidelines (and GNWT Registered Trade-mark Terms and Conditions of Use contained within this document) explain how the logo can and cannot be used. In summary, the NWT Arts Logo cannot be changed or altered in any way and must be used in its original form.

A copy of the NWT Arts Logo Use Guidelines and GNWT Registered Trade-mark Terms and Conditions of Use can be found on the NWT Arts website and are available from the Economic Development Officer in each community. By signing this registration form, I confirm that I have read and understand these Guidelines and Trade-mark Terms and Conditions, and agree to follow them.

## **Declaration**
